

## Kentbruck Green Power Hub Environment Effects Statement – Notice on exhibition documents and extension of public comment period

The Kentbruck Green Power Hub Environment Effects Statement (**EES**), together with draft Planning Scheme Amendment C116GELG to the Glenelg Planning Scheme, has been on public exhibition since 28 January 2025.

Neoen Australia Pty Ltd (**Neoen**) has become aware of some administrative errors which have resulted in the inadvertent omission of certain material from the material that was initially exhibited, or errors within the exhibited material.

Therefore, the public exhibition period has been extended to allow interested parties further time to review the exhibited material and make submissions. The EES and draft PSA documents are now available for public review until 11:59pm on Monday 31 March 2025.

This Notice provides a description of the errors or omissions that have been identified, and the action that Neoen has taken to rectify these matters is set out in the below table:
